The Board of School Trustees met in regular session on Wednesday, April 8, 2015, at the Board Office, 2020 N. Montgomery Road, Greensburg, Indiana 47240.

Board President Matthew Hoeing called the meeting to order at 6:00 p.m.

Under Old Business, Mr. Budd reported progress on the fieldhouses continues to be on schedule. They will begin concrete work soon and will then begin the finish work.

Under New Business, Mr. Budd recommended we accept the bid from Ricoh for new copier leases for the administration building and all four school buildings. On a motion by Lizette Bell and a second by Chris Owens, the copier leases from Ricoh were unanimously approved.

A donation from Obermeyer Agri Group for South Decatur Elementary's Archery Club was unanimously accepted on a motion by Brent Muckerheide and a second by Chris Owens.

Mr. Budd requested approval to accept an invitation to join the Economic Development Corporation. On a motion by Todd Mauer and a second by Annette Geis, Mr. Budd's appointment to the Economic Development Corporation was unanimously approved.

Mr. Budd requested the associate superintendent contract be restructured to a consultant contract with Equitable Education Solutions, LLC over the next four years. With approval of this restructuring Dr. Langevin will submit his resignation as associate superintendent effective June 30, 2015. On a motion by Chris Owens and a second by Brent Muckerheide the contract restructuring and resignation were unanimously

approved.

Mr. Budd addressed the issue of dismissal procedures at the North Campus. Todd Mauer and Brent Muckerheide stated they felt the dismissal process that was in place before Spring Break was the safest process and would like that made permanent. On a motion by Todd Mauer and a second by Brent Muckerheide, the dismissal process at the North Campus was approved by a vote of 5-0 to allow dismissal of the high school students first and the elementary students second. Matthew Hoeing and Tim Roscoe abstained.

Mr. Budd requested approval of a bid from Trane to provide new HVAC systems for the music rooms at North Decatur High School and South Decatur High School for a total cost of \$97,860. On a motion by Annette Geis and a second by Todd Mauer, Trane's bid was unanimously approved.

In his report, Mr. Budd reported on upcoming proms and graduation. He also reported on working toward next year in regards to scheduling, staffing and handbook changes

In his report, Dr. Langevin reported on the upcoming evaluation audit, social studies and science curriculum, and ISTEP, ECA & AP testing.


